Meeting Summary

I. AHSS South Sound Strategy Webmap Update - Brian McTeague, Squaxin Island Tribe

- Overview of updates for the Nearshore and Upland Maps see <u>user guide</u> for more details on the updates and how to use the enhanced functions.
- Walkthrough of new map functionality including adding layers/shapefiles
- Feedback on improvements and query functions

Discussion

 Questions were raised about individual layers and what they are showing and where those data sets came from (particularly about shoreline management).

II. Federal Funding Updates, State Legislative Session

- Puget Sound SOS (Federal)
 - Elevates the stature of Puget Sound recovery nationally. Creates a Puget Sound Recovery National Program Office at EPA.

- Coordinates alignment across AA, salmon recovery, Treaty Rights at Risk Initiative, Coastal Non Point Pollution Control Program.
- Serves as federal coordination point for Canada for Salish Sea
- o Codifies the PS Federal Leadership Task Force
- Selected annual appropriations increases:
 - Puget Sound Geographic Program (\$19m increase, \$54m total) to support projects in alignment with the Action Agenda.
 - National Estuary Program: Additional \$100k.
 - Coastal Watershed Grants (administered by Restore America's Estuaries): Additional \$500k (\$2.5million total)
 - \$3 million to the Northwest Straits Marine Conservation Initiative
- PSP Federal funding online reference
 - BIL Funding Tracker: List of upcoming Federal Grants (<u>Link</u>)
 - Repackaged as part of LIO Email Updates
- PSP legislative priorities
 - Support PS friendly GMA amendments and implementation (especially around salmon, climate, and population growth management)
 - Protect and restore riparian areas (pointing to Governor's stakeholder group recommendations)
 - Accelerate fish passage barrier correction implementation (greater state support for existing programs)
 - Protect and restore nearshore areas (strengthen monitoring programs, increase tools and incentives)
 - Fully fund capital grant programs for PS restoration (SRFB, BAFBRB, Centennial Clean Water Fund, PSAR, Floodplains by Design, ESRP)
 - Address toxic pollution from stormwater (6PPD/6PPD-Quinone)
 - Consider proposals for a rapid response capability to avoid or mitigate salmon die-offs (Salmon Recovery Council efforts in progress)

Discussion

- New EPA office will be located in Washington State
- DERT is asking the State Legislature for a grant to start up a Deschutes Watershed Council
- PSP is asking the State Legislature to fully fund this years budget request for grant program requests

III. The PSP Leadership Council is Coming to Town

- Background information on local forums, an opportunity for us to talk with the Leadership Council about our issues and showcase work in the watershed
 - Starting in 2020 Rotating Conference for each LIO (ECB & LC) to meet in person with LIOs and Les to address the intersection of local and regional recovery priorities (~2 hours)
 - Objectives:
 - Expand local decision-maker engagement with the Puget Sound recovery community
 - Discuss local priorities, and determine how the LC and region can support action to address those local priorities
 - Discuss regional priorities, and determine how they might be supported at the local level
 - Topics should be specific asks of the Leadership Council (write op-ed, talk to Ecology, help us determine next steps to x,y,z). Topics should relate to strategy documents/LIO plans or Action Agenda, and unique to specific issues within the local area that could use further clarification or support at a regional scale..

- Brainstorming what we want to bring forward
- Volunteers to work on this with us and PSP between meetings

- Dam removal and estuary restoration in South Sound successes and opportunities
 - Goldsborough Creek dam removal (success)
 - Oakland Bay / Shelton Harbor restoration (success and opportunity)

 - Chambers Bay (opportunity)
 - Deschutes Estuary (opportunity)
 - Nisqually (success and opportunity)
- Shellfish programs in South Sound success and challenges
 - o Importance of South Sound as a growing area
 - Longstanding coordination
 - Challenges as development and population increases WQ challenges, coordination challenges (more support is needed)
- Grant administration burdens and challenges
- Sea level rise challenges
 - Need for incentives to set back houses on unarmored shorelines
 - Climate resilience planning and coastal flooding
- Challenges of forest conversion and impacts of changes in upland forests on shorelines and nearshore (erosion, runoff); connection between what happens in the upland forests and the shoreline/nearshore; incentives for forest retention
