I. Welcome and Round Robin Updates

- South Sound Science Symposium Planning Underway for 2022
- Action Agenda is going to Leadership Council in June for approval. Public comment period is open till Jun 15th
- Pierce County is doing a comprehensive plan update. Including an update an update to the critical areas ordinance. 2028 shoreline update with a nearshore assessment is also being explored.
- WRIA 10/12 Lead Entity is doing a short video using Caravan Lab, on fish passage barriers in Pierce County
- Mason County Planning Department holding a workshop on improving relationship and sharing of resources/services

II. Project Lists in the LIO Geography

- Currently compiling existing lists of projects from across the LIO and organizing them in one place for awareness building and so we can look for opportunities to work together
- This includes the Lead Entity workplans, the Watershed Restoration and Enhancement project lists, Capital Facilities and Park Plans, Retrofit Plans, Culvert priorities/plans and others. We're interested in your suggestions and ideas for this work.
- Proposing a series of Focus Area workshops in late summer/early fall regarding culverts, nearshore and forests.
- Goal: To create a menu of present and future projects in the LIO Geography

- Why: To help project sponsors and other partners be in a better position to coordinate and collaborate and to receive Bipartisan Infrastructure Law funding opportunities.
- Help tell a better story about South Sound habitat restoration/acquisition/fish barrier removal projects, by linking various projects/proposals
- Make South Sound more competitive when funding becomes available

Discussion

- Many LIO members expressed interest in participating in Focus Area workshops to revise ERP
 content and be sure its up to date, review mapping tools and website content regarding focus
 area content and discussing individual/shared priorities.
- Discussion continued around what lists currently exist: Salmon Lead Entity Project Lists, PRISM, Salmon Recovery Portal, AA NTA Lists, Legacy Projects, PSAR workplans, Railroad funding and local (city/county) stormwater and Shoreline Management Plans, Capital Facilities and Park Plans and additional lists that already exist.
