- City of Tacoma is hiring Engineer with experience with NPDS Stormwater compliance
- City of Tacoma turned in second set of comments for EPA stormwater discharge permits
- Desiree Radice taking over Meritas role as being involved with AHSS
- Puget Sound Day on the Sound will take place at the Nisqually Cultural Center on Oct 8 Rep Kilmer and Strickland will be present
- Register for the Annual Salmon Bake at Nisqually Land Trust hosted by Willcox Farms on Oct 2nd
- South Sound Science Symposium will take place Oct 20th at Squaxin Island

II. Project Lists in the LIO Geography

- Currently compiling existing lists of projects from across the LIO and organizing them in one place for awareness building and so we can look for opportunities to work together
- This includes the Lead Entity workplans, the Watershed Restoration and Enhancement project lists, Capital Facilities and Park Plans, Retrofit Plans, Culvert priorities/plans and others. We're interested in your suggestions and ideas for this work.

- Proposing a series of Focus Area workshops in late summer/early fall regarding culverts, nearshore and forests.
- Goal: To create a menu of present and future projects in the LIO Geography
- Why: To help project sponsors and other partners be in a better position to coordinate and collaborate and to receive Bipartisan Infrastructure Law funding opportunities.
- Help tell a better story about South Sound habitat restoration/acquisition/fish barrier removal projects, by linking various projects/proposals
- Make South Sound more competitive when funding becomes available

- Update on ArcGIS StoryMap on nearshore restoration in the watershed
 - Salish Sea Marine Survival Study Salmon Restoration, South Sound Nearshore GIS Map highlighting Estuaries, (setting scene)
 - Examples of estuary restoration (Shelton Harbor and Mission Creek)
 - Squaxin Coastal Catchment Analysis & LIO Potential projects
 - Remaining/Pending Nearshore Projects in the LIO Geography
- Full table of mapping updates will be linked in the next round of LIO email updates

Discussion

- Consider double checking whether non intact pocket estuaries are included in the mapping tool
- Add layers for changes in shoreline (historic vs current)
- Make it easier to access the mapping tool on the website
- Consider adding WRIA 13s priority freshwater reaches to the data layer options
- Query tool will be improved and could include suggestions for additional prepopulated queries
- Consider adding information that shows improvements with numbers in the watershed
- Double check if dissolved oxygen layers are included in the layer updates
- Add videos to the story map layers, highlight local narratives and consider PSP production support
- Peirce County willing to share paper map they have developed
- Consider working with PLU/CPTC courses on developing the stories to embed into the story map

- Thurston County to remain Fiscal Agent for LIO
- Ross Strategic to remain contractor for LIO coordinator role
